Subject:- Conditional Permission to Krishna Ayurved Medical College, Edu Campus, Vadodara- Mumbai NH 8, Varnama, Vadodara-391240, Gujarat (Inst. ID. AYU0541) with 54 seats (instead of 60 seats) in UG (BAMS) course under section 28 of NCISM Act, 2020 for the academic session 2023-24-regarding.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021.

- Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college namely **Krishna Ayurved Medical College, Edu Campus, Vadodara- Mumbai NH 8, Varnama, Vadodara-391240, Gujarat (Inst. ID. AYU0541)** inspection of your College was conducted on **02.05.2023 & 03.05.2023 on Hybrid mode** as a part of annual visitation by the visitation team of Medical Assessment and rating Board, NCISM to process of **Conditional Permission with 60 seats in UG (BAMS) course for the academic session 2023-24 under Section 28 of NCISM ACT 2020 and relevant regulations thereunder.**
- Further, in view of above, the visitation report and all other related documents were assessed in terms of enforced regulation namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", and provisions under the NCISM Act, 2020 and relevant Regulations there under. On examining the case in light of above notified and approved criteria and on perusal of the visitation report, it was observed that the college was not fulfilling the basic eligibility criteria due to following shortcomings: -

1. Teaching Staff :-

- Availability of total teaching staff is $\frac{\text{Available}}{\text{Required}} \times 100\% = \frac{26}{30} \times 100\% = 86.66\%$ (excluding Excess and after considering visitor observation report)
- Shortcomings in teaching staff are as under:

- No deliveries conducted from 1st jan 2022 to 31st dec.2022,

3. The Continuation of Affiliation issued by the Gujarat Ayurved University for the academic year 2023-24 has not been submitted.

- In view of above, the assessment report was placed in the **48th Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) on **20.07.2023**. On careful examination of the assessment report, considering the deficiencies observed therein as mentioned above the college was given an opportunity of virtual hearing vide the MARBISM letter (Hearing notice) of **even no. dated 02.09.2023** to appear on **06.09.2023** before the designated Hearing Committee to present their case and to show cause as to **why not the conditional permission to your college with 60 seats in UG (BAMS) course under section 28 of NCISM Act 2020 be denied for the Academic Year 2023-24.**
- The college was directed to make written submission in respect of the case and produce all relevant valid documents/records/proof against all the deficiencies/shortcomings as indicated above. The representatives of the college submitted written submissions **vide Ref. no nil dated nil** against the deficiencies conveyed to them. Whereas, the college through its representatives, **Dr. Mallhari Sir Deshpande, Principal** appeared before the Hearing Committee on **06.09.2023** and made their submission virtually as well as written submission against the shortcomings communicated to the college. The

shortcomings communicated to the college, submission made by the representatives of the Ayurveda college and observations made by the Hearing Committee are as under:-

However, while submitting the online Part-I Performa, we could include only 31 Teachers as the process of linking codes & Appointment of 4 Teachers was pending with NCISM (Attached Email sent to NCISM before submission of Part-I). We have also submitted annexure I with the signature of visitors on the day of visitation. Out of 35 faculties, 34 were present on the day of visitation & one teacher was on informed leave (Attached Copy of Annexure I) We request you to consider this fact as we fulfill the requirement as per the MSR regulation schedule V (iii)</p> <p>1b).1&3Sir, we are continuously trying to recruit the needed staff. Recently we have appointed one Reader in Kayachikitsa, Dr Mithun C K (Teacher Code: AYKC01840) & he has already joined our college on 1st Aug 2023. Dr. We have also send request for linking his code in the portal. Attached Appointment letter, joining letter & all certificates with the print of application made through online portal. Further we have also issued offer letter for the post of Professor in Kayachikitsa. Dr P Gaurishnakar would be joining as Professor in Kayachikitsa shortly (Offer letter & consent attached). Further, we have also appointed one Lecturer in Swasthavritta & Yoga named Dr. Jivan Hanawate (Teachers Code AYSV00916). He has recently joined on 1st September 2023. The PHC in Varnama is running various government schemes for deliveries in which the mother and child are given monetary benefits under the schemes. Though we have well equipped labour room and well qualified team of consultants in Prasutitantra & Streeroga department, deliveries are preferred at the PHC by the women. We send our students to the Bharuch Medical College for attending deliveries and also we have a MOU with local Savita Hospital for this purpose. 5. The observation of hearing committee based on the submission made by the college representatives during hearing and assessment report of the NCISM have been carefully re-examined in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", and provisions under the NCISM Act, 2020 and relevant regulations thereunder, **and once again as per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM)**, the recommendation of Hearing Committee was placed in the **58th Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) **held on 14.09.2023.**

6. In view of the observation of Hearing Committee based on the submission made by the college representatives during hearing and assessment report have been carefully examined in terms of concerned Regulation and provisions under the NCISM Act, 2020 and relevant regulations thereunder, and board decided that the college **is not fulfilling the basic eligibility criteria for Grant of Conditional Permission to Krishna Ayurved Medical College, Edu Campus, Vadodara- Mumbai NH 8, Varnama, Vadodara-391240, Gujarat (Inst. ID. AYU0541) with 60 seats in UG (BAMS) course under section 28 of the NCISM Act, 2020 for the academic session 2023-24, but Board decided to issue conditional permission as per the approved Seat Reduction Policy in accordance of Section 28 (1) (f) of NCISM Act 2020 for failing to maintain the minimum essential standards for the Academic year 2023-24.**

"For deficiency of every one teacher, seat reduction in the intake capacity shall be considered by reducing the intake strength by 10% of total intake capacity."

Accordingly as per Schedule-V Note (iii) of MSR 2016 the deficiency of teacher for up to sixty intake capacity shall not exceed more than ten percent of total requirement. As per the Hearing Committee observation and approval of Minutes in the 58th Board meeting of MARBISM, college is having only 26 total eligible Teaching faculty.

*There is deficiency of 01 teacher for issuance of conditional permission for academic session 2023-24 as per Schedule-V Note (iii) of MSR 2016. **Therefore, in accordance of Reduction policy 2023-2024, for deficiency of every one teacher, seat reduction in the intake capacity shall be considered by reducing the intake strength by 10% of total intake capacity.***

*Accordingly, after applying the seat reduction policy 2023-24 under section 28 (1) (f) of NCISM Act 2020 college is fulfilling the basic eligibility criteria for issuance of **conditional permission with 54 seats (instead of 60 seats) in UG (BAMS) course under section 28 of NCISM Act, 2020 for the academic session 2023-24.***

7. Therefore, in view of shortcomings and deficiencies mentioned as above and after applying seat reduction policy for the academic year 2023-24, **Conditional Permission is granted to Krishna Ayurved Medical College, Edu Campus, Vadodara- Mumbai NH 8, Varnama, Vadodara-391240, Gujarat (Inst. ID. AYU0541) with 54 seats (instead of 60 seats) in UG (BAMS) course under section 28 of NCISM Act, 2020 and relevant regulations thereunder for the academic session 2023-24.**

i. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

ii. It is further informed that minimum **15% of undergraduate seats of the permitted intake capacity with 54 seats (instead of 60 seats)** shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2023-24 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**

iii. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.

8. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.

9. Further, **as per Sub-section (7) of Section 29 of NCISM Act, 2020**, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly

or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then **in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or subsequent year.**

10. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
11. **The following requirements should be fulfilled by the college by 31st December, 2023 and send a compliance report to get permission for the academic session 2024-25:**
 - (i) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - (ii) All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - (iii) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto;
12. The fulfillment of the shortcoming mentioned in the observation of Hearing Committee and the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2024-25.

2. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016" and provisions under the NCISM Act, 2020 and relevant Regulations there under, and on the basis of Relaxation policy issued by the NCISM dated 16.03.2022.
3. As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the **Sixteenth Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **07.11.2022**. On careful examination of the assessment report it is found that **your college is fulfilling the notified & approved criteria, hence Board decided to issue the Conditional permission with 60 seats in UG (BAMS) course for A.Y. 2022-23.**

The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
 - II. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 60 UG (BAMS) seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2022-23 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college**

fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.

It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide no.BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
5. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
6. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
7. **The following requirements should be fulfilled by the college by 31st December, 2022 and send a compliance report to get permission for the session 2023-24:-**
- i) all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
- ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
- iii) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto; and
8. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission from the academic session 2023-24.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provisions of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-section (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) has been dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government notified that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021. In view of the above the Central Government constituted the Autonomous Boards with effect from 11th June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder.

Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

2. However, GOI, Ministry of AYUSH vide its letter no. L.14011/3/2020-EP (1) dated 26.03.2021 and 15.04.2021 issued Relaxation/support policy for ASU&S colleges in unprecedented times of COVID-19 pandemic for the academic session 2021-22 and the colleges will be considered on the basis of part-I visitation proforma submitted by the college provided that the college shall submit an undertaking & indemnity bond, stating that they shall fulfill respective requirements in terms of required teaching and training facilities specified in the relevant regulations throughout the academic year. Further, as per point no. "P"

of above said relaxation policy and as per direction of President, Medical Assessment and Rating Board for Indian System of Medicine, college was virtually visited on dated 06.10.2021."

Further, in view of above, the college has been assessed on the basis of Relaxation policy issued by the Ministry of AYUSH and visitation report submitted by the visitors. On examining in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", Indian Medicine Central Council (Post Graduate Ayurveda Education) Regulations, 2016, provisions under the NCISM Act, 2020 and relevant regulations thereunder, it is found that the College is fulfilling notified and approved criteria for Granting Conditional Permission for UG (BAMS) course for A.Y. 2021-22.

3. Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine **to grant Conditional Permission to Krishna Ayurved Medical College, Bits Edu. Campus Vadodara-Mumbai NH 8, Varnama, Vadodara-391240, Gujarat (Inst. ID. AYU0541) for conducting 60 seats in UG (BAMS) course for the academic session 2021-22** subject to the following conditions:-

- I. The fulfillment of conditions as specified in the Undertaking/Indemnity bond submitted by the college.
 - II. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

I am directed to refer to the Ministry's letter No. L.14012/5/2019-EP (1) dated 29.10.2019 related to admission matter for the academic year 2019-20, intimating certain requirements to be fulfilled by the college for consideration of permission for the academic session 2020-21.

2. Further, refer to the CCIM's letter No.26-132/2020-Ay. dated 15.12.2020 forwarding therewith recommendation of the college to the Central Government based on thorough examination of the visitation report Part-I, indemnity bond, affidavit & latest details of teaching, non-teaching and hospital staff submitted by the college along with the assessment report, as the physical verification by conduction of inspection could not be carried out in view of present COVID-19 pandemic situation for the A.Y. 2020-21. On examining the same, certain deficiencies have been observed and therefore, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 14.01.2021 to present the case through virtual mode.

3. The observations of hearing committee based on submission made by the college representatives during hearing and recommendations & assessment report of the CCIM and its letter dated 04/02/2021 related to revised status of teachers in respect of withdrawal of teachers code, have been carefully examined in terms of Regulation 3 of the “Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016”, provisions under the IMCC Act, 1970, relevant regulations made thereunder and it is found that the College is not fulfilling notified and approved criterion for granting Conditional Permission for UG (BAMS) course for 60 seats.

4. Further, the said college has also been examined in terms of approved criteria and policies exclusively relaxed for A.Y. 2020-21, for UG (BAMS) course. Therefore, the college is found eligible for 30 UG seats (instead of 60 UG seats) for the A.Y. 2020-21 (considering the relaxation for deficiency in teaching faculty as per the said relaxed criteria). The College has also consented to reduce capacity from 60 UG seats to 30 UG seats exclusively for A.Y.2020-21 vide their letter dated 05.02.2021

The counseling for seats under all India quota shall be conducted by respective counseling authority of State/UT Government as designated by Central Government vide letter F.No.L.11011/02/2020-EP (1) dated 26.10.2020 for A.Y. 2020-21 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for all India quota or the students admitted thereunder.**

7. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under IMCC Act & Regulations made thereunder.

8. Discrepancies, if any, may be immediately brought to the notice of Board of Governors, CCIM and the Central Government.

9. As per clause 3 (1) (a) of IMCC, MSR Regulations, 2016 the following requirements should be fulfilled by the college by 31st December, 2020 will be examined for considering the permission for the session 2021-22;

- (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 and 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;


8. The college administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the relevant CCIM Regulations, are in position before the admission of the first batch of students in the 1st professional of BAMS course is made, under intimation to the Central Government and CCIM.

9. The college has to develop the requisite infrastructure for IInd, IIIrd and IVth professionals well in time as per the CCIM norms which will be verified and reported by the CCIM at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.


